#### Father accused of murder shows girl's photo to court

#### Saturday, August 22, 1998

According to police statements contained in court files, McNeil repeatedly blamed his girlfriend, who police have ruled out as a suspect. McNeil said two small holes in the bedroom window screen proved she lifted up the screen, crawled through the window and smothered the girl in the bed, police say.

Authorities do not accept his explanation that an intruder, perhaps a woman he knows, broke into his home on North Evans Street late June 15 or early June 16 and smothered the girl.

## Judge limits evidence in B-N child-killing case

February 4, 1999

A McLean County judge ruled Wednesday that only limited evidence may be presented suggesting another suspect might have murdered the child of a Bloomington man who now stands accused of smothering his 3-year-old daughter.

## Judge disallows McNeil new evidence March 5, 1999

A McLean County judge ruled Thursday that despite new evidence, defense attorneys for murder suspect Barton McNeil will not be allowed to argue that his ex-girlfriend smothered his 3-year-old daughter.

McNeil, 39, of the 1100 block of North Evans Street, has maintained that Misook Nowlin, who prefers to go by the name Misook Kim, entered his apartment while he was asleep and killed his daughter, Christina, last June.

Authorities have ruled out Kim as a suspect.

## Sex abuse angle approved in B-N father's murder trial

#### March 20, 1999

McNeil has maintained that his ex-girlfriend, Misook Nowlin, who prefers to go by the name Misook Kim, was responsible for his daughter's death. Authorities have ruled out Kim as a suspect and Prall ruled in an earlier hearing that defense attorneys will not be allowed to argue she killed the girl.


## Judge denies more DNA tests in child-slaying case

### Trial begins in McNeil murder case July 2, 1999

In the same statement, McNeil said he's certain his daughter died of asphyxiation and he believes a woman that he had a bitter break-up with was responsible.

### McNeil gets life in prison August 12, 1999

Barton McNeil denied killing Christina in his testimony at trial and in taped statements to police. He theorized that an intruder must have climbed through a bedroom window and killed the child while he slept in another room.

When offered an opportunity to make a statement prior to sentencing, Barton McNeil launched into a 45-minute discourse in which he raged that police failed to adequately investigate the case and griped that his defense was hampered by pretrial rulings which barred his defense team from presenting evidence pointing to the woman he claims is the killer.

### Transcript of McNeil addressing the court:

MR.McNEIL: If I can get anything out in allocution or anything, and if this leads to saving whoever the next victim is, I don't care. I don't care if I spend the rest of my life in prison.
