Bart unknowlingly shared info enabling Misook to go home and dispose of evidence

Barton had mentioned that He wanted to speak to Misook because he could get her to confess. I asked Misook if she wanted to see Barton. She said she did. I brought Det. Burns, Wikoff and Doza into the room in case of any physical confrontation. I then brought Barton into the room. Barton seemed startled that I would allow him to talk with Misook and when he entered the room Misook asked him why he was doing this that She loved him. Barton told her that she was a psycho bitch and that She murdered his daughter. He asked her if she had her "toy's" still at home. He said that she used one on Christina and then killed her. Misook told him that he was the psycho one and that he must have done something to his daughter and She could not believe he was trying to say that she did it. Barton told her that she had crawled through the window and suffocated his daughter. Misook told him again that he was the Physco. Barton then called Misook a psycho fucking bitch and said that he hated her and has hated her for 3 years and has been trying to get rid of her. At this point I believed that this was not going to be fruitful any longer. I then had Barton go back to his interview room. I asked Misook if she would be willing to take a polygraph test and she didn't understand what it was. I told her a lie detector test and she was adamant about taking one. I told her that she was free to go but that I would probably need to talk to her again at a later time. She then left. I was called about 5 minutes later and advised that Misook had passed out in the front parking area of the Police Dept. I went down there and Rescue personnel had arrived they advised that she was hyper ventilating. She was taken to the hospital. When She was on the ground having a hard time breathing and complaining of chest pains I could hear her saying that she couldn't believe Bart would say something like that. She was unaware that I was there as her eyes were closed because she was complaining of blurred vision.



During the course of the polygraph examination, this examiner also experienced some communication difficulties with the subject.

There were erratic and inconsistent responses on the subject's polygraph records which preclude the examiner from rendering an opinion on the following questions:

On June 16 (1998) did you suffocate Christina McNeil at Barton McNeil's

apartment? Answer: No

Did you suffocate Christina McNeil?

On June 16 (1998) did you enter Barton McNeil's apartment between midnight and seven A.M.?

Answer: No

When you are the assigned "Lead Detective" in a murder case, the first in 2-years in Bloomington, so a high profile assignment no doubt, and you've already during the Grand Jury proceeding 2-weeks ealier declared that you have eliminated Misook as a suspect this is what you do when you receive a polygraph exam that doesn't support your position. You minimize it.

I added to the case file the results from Terry McCann's polygraph examination of Misook Nowlin. McCann advised that He was unable to render an opinion but did agree with Det. Arnold and Myself that Nowlin had nothing to do with Christina's death and that She is being truthful. McCann believes that the problem is that Nowlin is of Asian descent and there is a communication barrier between the two of them. Apparently Detective Shepherd decided not to inform Polygraph administrator "McCann" that Misook was full-time employed by Anderson Financial, in turn a subtractor to AT&T mobile, to provide English to Korean (and vice versa) translation services for Korean mobile phone customers. Misook had enough of a command of the English language, as did her best friend Yuman Aldridge, to meet and marry two U.S. servicemen in Korea before emigrating to the United States to be with their husbands. At the time of the Christina McNeil murder, Misook had lived in the United States since 1989, so roughly ten years at the time the Polygraph exam was administered.

NONE took a core body temperature that is the most sure way to determine time-of-death. Instead only as the trial nears, with dozens of Discovery pages, polygraph exam, etc., showing it was a post-midnight murder, did McLean County suddenly bring back then-fired McLean County Pathologist Dr. Violette Hnlinica back to write a report and render her professional opinion that Christina did not die at a post-midnight hour, but instead that she died between 10 pm and 11 pm. Based on flawed and known-to-be-faulty gastronomic contents (digested food) in Christina. Despite Bart having told everyone he saw his daughter last awake at approximately 12:30 a.m. with her being murdered between then and when he awoke so that Misook have as best an alibi she could for this critically important time period. With Misook's 8 pm - 11 pm whereabouts at the ISU pool hall supported by her best friend Susi Kaiser, also from Korea, and her future husband-to-be, Don Wang.
