COMES NOW, the State of Illinois, by and through Assistant State's Attorney Jennifer McCoskey and hereby requests that an Order be signed, pursuant to and, in accordance with, 18 United States Code (U.S.C.), 2703(d.); requiring the herein named utility to furnish all cellular phone records; including call detail (incoming and outgoing) including all numbers dialed, beginning and ending location of calls, direct connect calls, caller identification(s), IAP system identity, cell tower location (including latitude and longitude), cell tower database information and cellular site information, for the listed phone number. And, to furnish to the Bloomington Police Department, through the below named detective and/or his/her designee(s), as soon as practical and at reasonable interval(s) during regular business hours, or, during non-business hours during emergency/exigent situation(s), for the duration of the order.

- I. The utility is **T-Mobile**, a cellular provider.
- II. The cellular telephone number is
- III. The release of said cellular phone records, technical information, and technical assistance are material to a murder investigation; supporting information/"specific and articulable fact(s)" are as follows:

PROBABLE CAUSE STATEMENT

Detective Matthew Dick is a detective with the Bloomington Police Department. As a regular part of affiant's duties, affiant conducts investigations into criminal offenses, interviews witnesses, collects and preserves evidence connected to the investigations. Detective Matthew Dick assisted in an investigation

conducted by the Bloomington Police Department regarding a missing person report from Crest Hill, Illlinois.

is the mother-in-law of Misook Wang. Wang believed that her husband, Don Wang, was cheating on her so she went to his place of employment and asked that he be fired. The owner of the business told Don Wang that he was no longer employed until his personal life was put back in order. then called the business owner and asked that her son be returned to work. Wang found out that called the business owner and got very angry.

On 9-1-201, Wang traveled to home in Crest Hill, Illinois, and confronted husband threatened to call police and Wang left. One 9-4-2011, Don Wang went to house in Crest Hill because he was scheduled to fly out of O'Hare Airport at 7:30pm to Los Angeles, California. While told him that she received a phone call earlier in the day requesting Don Wang was at house. her translation services for September 5, 2011. The caller asked to come to Bloomington, Illinois, to the Cub Foods parking lot at 5:30 am on September 5, 2011. Once there, was to translate for and to transport a client to Chinatown in Chicago. Don Wang told to call the client to see if they would wait for his return from Los Angeles, so that he could accompany told him that the client wouldn't want to wait and that she was fine doing this job alone. left her Crest Hill, Illinois home at 3:15am on September 5, 2011. She kissed her husband goodbye and that is the last time she was seen or heard from.

did not return home by the evening hours of September 5, 2011, and he couldn't reach When husband reported her missing to the Crest Hill Police Department. Since her by phone, lived in Bloomington and her last known whereabouts were in Bloomington, the Crest Hill Police Department requested Bloomington Police Department's assistance. BPD started their investigation and son. As part of their investigation, they also made interviewed several people, including Don Wang, contact with a hostess at the Hibachi Grill in Bloomington, Hui Lin. Lin told police that on September 4, 2011, a woman came into the restaurant and asked if anyone spoke Chinese. Lin replied that she did, and the woman offered to pay her \$20 to make a phone call in Chinese to a woman named " Lin agreed and went outside to the woman's car. Lin called " and asked her to pick up a client at Cub Foods parking lot on September 5, 2011, at 5:30am. agreed to complete the job for \$500. Lin identified the woman who asked her to make the call as Misook Wang. Surveillance video from Cub Foods on the morning of September 5, 2011, shows vehicle arriving in the parking lot. Wang's silver Mercedes SUV is then seen arriving on the video. It appears that there are two people in Wang's vehicle. There is a struggle and then someone is seen getting into vehicle. Both vehicles then leave the parking lot.

Search warrants were obtained for Misook Wang's residence, business and person on September 12, 2011, and executed on September 13, 2011. A search of the dumpster outside her business at 2412 E. Washington Street, Suite 7B, Bloomington, Illinois revealed a garbage bag with identification and credit cards that had been cut up.

Initially when interviewed on September 12 – 13, 2011, Misook Wang denied having any contact with or seeing on September 5, 2011. When confronted with the information about the restaurant hostess making a call for \$20, Wang admitted that she had the hostess call to have her come to Bloomington on September 5, 2011 and to meet her at Cub Foods parking lot. Wang then said she met with the victim on September 5, 2011 at Cub Foods and there was an argument between her and She then claimed that left the Cub Foods parking lot and she hadn't seen her since. When Wang was confronted with the items found in the garbage, she eventually admitted that was dead. She stated that followed her to her business and there was a physical altercation in the parking lot. She claimed that the 70 year old attacked her first and tried to kill her. She admitted to using both hands to apply pressure to

neck and "choked" her. She did this for 5 to 10 minutes and then dragged the body into the business where was making gasping noises. Wang lied on the couch for some time because she was tired. died and she hid her body in the back corner of the business. She drove car up to Chicago and abandoned it at the airport, taking the bus back to Bloomington. She then bought a plastic storage container at Lowe's and covered it with a blanket. Later that same day she also bought a shovel from Lowe's. She left the body at her business until the evening hours of September 6, 2011. At that time she loaded up in the plastic container and drove her to the Des Plaines Wildlife Preserve. Once there, Wang drove back into a wooded area and buried. She showed police where she buried and an autopsy was conducted on September 13, 2011. The medical examiner found hemorrhages on neck consistent with Wang's version of applying pressure to the neck.

At this time, it is unknown if Wang acted alone or conspired with one or more people. Phone records to include tower access data and text message content for the cell phones of subjects involved will assist in the investigation of Wenlan s death, including establishing the movements of Don Wang around the time of the incident and confirming his trip to California. Don Wang has 3 known cell phone numbers, one of which is through T-Mobile.

This probable cause statement references the facts used to charge McLean County Case 2011 CF 800.

WHEREFORE, Petitioner respectfully requests that an order, consistent with this Application and subsequent technical wording of said order, be granted. Further, that the utility be ordered not to reveal to anyone that this order exists.
